Pursuant to the FREEDOM OF INFORMATION ACT (FOIA), 5 U.S.C. § 552, et seq., I hereby request certain records from the United States Food and Drug Administration (herein "FDA") concerning currently active certifications pursuant to 21 C.F.R. 900.11 to operate a mammography facility and any applications for such certificates during the prior 5 years.

DOCUMENTS REQUESTED

- 1. All currently active certificates to operate a mammography facility issued by the FDA or by any state or other entity designated to provide such certificates by the FDA for Planned Parenthood Federation of America, any affiliate of Planned Parenthood of America, or any entity whose name includes the phrase "Planned Parenthood."
2. For the prior 5 years, any applications or submissions to the FDA or its designees concerning a certificate to operate a mammography facility from Planned Parenthood Federation of America, any affiliate of Planned Parenthood of America, or any entity whose name includes the phrase "Planned Parenthood."

If FDA determines that any responsive record requested qualifies for an exemption under the Act from disclosure, in whole or in part, please identify the record or portion of the record claimed to be exempt and cite the specific statutory exemption FDA believes applies to the record or portion of the record. If FDA determines that any responsive record requested or any portion thereof qualifies for an exemption under the Act from disclosure, please advise me whether the exemption is discretionary under the Act and, if so, whether it is necessary in this case to exercise the discretion to withhold the specific record. In any event, please provide a

signed notification citing the legal authorities on which FDA relies if FDA determines that any or all of the records requested are exempt and will not be disclosed.

In the event that duplication costs for requested records are less than \$100.00, you may proceed to duplicate the records and provide them to me; your bill will be paid upon receipt. In the event that the cost of copies of the requested records will exceed \$100.00, please let me know when I may have access to the requested records to view the requested records to determine which records to ask to have duplicated.
